<u>Call to Order and Introductions:</u> Chuck Adams called the meeting to order at 12:00 p.m.

<u>Opening Ceremonies:</u> The <u>Invocation</u> was given by Tim McLane. He conveyed Chapter condolences on the passing of Compatriot Earl Higginbotham and Paul De Paul, father of Compatriot Steve De Paul. He expressed well wishes and a speedy recovery from recent surgery to Compatriot Tom Carpenter Jr. Chuck Adams led the participants in reciting the <u>Pledge of Allegiance</u> and the <u>SAR Pledge</u>.

<u>Approval of Minutes:</u> A **Motion** was made by Mark Snider and seconded by Steve De Paul to approve the meeting minutes of May 13, 2023. Unanimously approved.

## Officer's, Committee's and 250th Anniversary Recognition Reports:

#### President & Registrar/Genealogist - Chuck Adams.

Genealogy & Membership. Chuck Adams recognized the presence of our recently approved newest members and their wives, Scott (Lynne) Moore and Cliff (Janice) Dickinson. Our newest applicant, Peter DeWick is present as well as prospect, Lincoln Pero. Not present are prospects Jim McHugh and Gary Van Sciver. Chuck stated that previously submitted supplemental applications still under review include Martin Hollick, Kevin Shurte, and his ninth. He said that year to date our membership has increased from 59 to a net of 72, including the recent reinstatement of Ronald Goodale.

FLSSAR BOM May 19-20, 2023. Chuck Adams reported on the May 2023 Board of Management (BOM) meeting which he along with Steve De Paul and Kevin Shurte attended. He stated that the Chapter Color Guard was considered officially formed on May 19, 2023, and that Kevin is the first from our Chapter to have participated in the BOM Color Guard presentation of colors at the two evening banquets. He announced that the Chapter won second place for mid-sized chapters in the 2022 Chapter Challenge which was presented to us at the May 2023 BOM. At that meeting he learned that all members participating in youth programs and the color guard are expected to take the online NSSAR Youth Protection Training Course.

250 Anniversary Recognition Program. Chuck Adams explained the purpose of the program and outlined how the Chapter will recognize a historical event in every forthcoming Newsletter and Chapter meeting. He stated that he and Kevin Shurte will co-chair the 250<sup>th</sup> Anniversary Recognition Committee and that each month a significant revolutionary war era event occurring between 1764 and 1783 will be featured and summarized. He briefly discussed the Battle of Bunker Hill fought on June 17, 1775, as the Chapter's first 250<sup>th</sup> Anniversary Recognition Event.

Upcoming Events. Chuck stated that he along with Steve De Paul and Kevin Shurte will represent the Chapter at the July 15 - 20, 2023,  $133^{rd}$  National Congress. He said that Mark Snider will also attend to help with registration for the first couple of days.

Newsletter & Member Profile. The June 2023 Newsletter has been circulated and posted. It includes the Member Profiles of Scott Moore and Cliff Dickinson who are being inducted today.

#### Secretary – Mark Snider.

Executive Committee. Mark Snider reported that the Executive Committee met on June 14, 2023, with all members present except Steve De Paul who had an unavoidable conflict. After the acceptance of the resignation of Joe Motes from the position of Historian, Chuck Adams introduced a **Motion**, made by Pete Stevenson and seconded by Tom Shepherd, appointing Kevin Shurte to serve as Chapter Historian during the 2023 unexpired term of Joe Motes, subject to the final approval of the general membership at its scheduled meeting of June 17, 2023. Unanimously approved. The Executive Committee also approved making a \$250 donation to Honor Flights South Florida in memory of M. Earl Higginbotham, and it approved the most currently updated Amended Budget as of May 31, 2023.

Veterans Support and U.S. Stark Memorial Award Committee Report. Mark Snider reported that the approvals were received appointing him as Representative and Chuck as Deputy Representative to the Veterans Administration Voluntary Service (CDCE/VAVS) Committee. He stated that that we currently have 1,660 points documented for the U.S. Stark Memorial Award which includes the donations to the Nininger Nursing Home. All members are reminded to submit any activities performed in the service of Veterans to Mark Snider.

Nininger Veterans Nursing Home. The Veterans Support Committee has organized and the Chapter will host a Donut Saturday on June 24, 2023, starting at 10:30 a.m. at the Alexander Nininger State Veterans Nursing Home. The Chapter is donating over \$550 in equipment for the facility consisting of a wheeled popcorn cart, an air fryer, a mobile dry erase whiteboard, and two big button TV remotes. These items will be presented as part of the event. All members are welcome to attend and a reminder notice will be e-mailed.

Vietnam War Commemoration. Mark Snider stated that he attended the Vietnam War Commemorative Welcome Home program in Washington DC last month. He received award pins and other items to be presented to our qualifying Veterans. The Chapter also received a Commemorative Flag and Certificate from the U.S. Department of Defense.

**Treasurer & Editor – Joe Motes**. Joe reported that all year to date transactions are recorded on the provided Status of Fund Report. As of May 31, 2023, the rounded balance in the checking account is \$5,784 and it is \$1,348 in the savings account. Chapter funds invested in U.S. I-bonds, including accrued interest, is \$3,730. Trust Estate funds invested in U.S. I-bonds, including accrued interest, is \$16,417. Chuck Adams reported on the Amended Budget and the new Program Activities Schedule as of May 31, 2023. He said that the new schedule ties to the ending balance of the amended operating budget. Its purpose is to show, in detail, the expenditure plan

as relates to uses of: 1) Chapter funds, 2) Chapter advances on costs fully or partially reimbursed from the FLSSAR trust fund, and 3) costs funded from the donations received from private entities.

Youth Programs. Joe Motes reported on the various schools he has attended in awarding JROTC medals and certificates. Steve De Paul commented on the enthusiasm of the recipients that he observed at the ceremony he attended representing the Chapter.

<u>Election of Succeeding Chapter Historian</u>. Chuck Adams introduced a **Motion** made by Joe Motes and seconded by Tim McLane, electing Kevin Shurte to serve as 2023 Chapter Historian for the unexpired term of Joe Motes. Unanimously approved.

<u>Induction of New Member Compatriots</u>. Chuck Adams inducted Compatriots Scott A. Moore and W. Cliff Dickinson. Ted Duay explained the purpose of and presented the Rosette recognition lapel pin to both Compatriots.

<u>Presentation of Memorial Membership Certificate.</u> Chuck Adams presented the SAR Memorial Membership Certificate for Eugene Spear to his brother and sponsor, Compatriot Michael Spear.

<u>Presentation of SAR Membership Award Certificates</u>. Chuck Adams presented the SAR 5 Year Membership Award Certificate to Jim Clark. He acknowledged other members having anniversaries as published in the June 2023 Newsletter.

Presentation of Chapter Meritorious Service Medal. Chuck Adams, assisted by Steve DePaul, presented the Chapter's Bronze Meritorious Service Medal to Jim Lohmeyer. Chuck report that since first joining the Chapter on September 9, 2004, that Jim has significantly contributed to the maintenance and development of the Chapter including service as: 1) President, 2007 & 2009; 2) Vice President, 2006 & 2008; 3) Secretary, 2014 to 2017; 4) Genealogist/Registrar, 2017 & 2018; and 5) Chaplain, 2021 - 2023. In addition to these elected positions, he has served as Chapter Representative from 2012 to 2020 on the Veterans Administration Voluntary Service (CDCE/VAVS) Committee for the William "Bill" Kling VA Outpatient Clinic serving Broward County.

#### Unfinished Business/ New Business/ Announcements (Next Meeting 07/29/2023).

Chuck Adams reported that the Color Guard Committee will have a Zoom meeting scheduled shortly to finalize administrative and procedural matters. Any member attending the 133<sup>rd</sup> Congress in military attire can participate in color guard activities and earn national points. Joe Motes said that the next Zoom meeting of the Veterans Administration Voluntary Service (CDCE/VAVS) Committee will be conducted on the third Tuesday of July 2023 and that Mark and Chuck should receive an e-mail invitation.

<u>Closing Ceremonies</u>. The **Benediction** was given by Tim McLane. Chuck Adams led the participants in reciting the **SAR Recessional**.

**Adjournment.** Chuck Adams adjourned the meeting at 2:30 p.m.
