PRESIDENT'S MESSAGE

Compatriots and Friends,

Time for a break! We have our lunch meeting on July 19, 2025 and then we break until our next lunch meeting on September 13, 2025. HOWEVER. Our next Color Guard event is the welcome home of Honor Flight South Florida Flight # 36. This event is for all members, spouses and friends of the Chapter. Join us on Saturday, Sept. 6, 2025 by 8:00 p.m., Terminal 4, Spirit Airlines, FTL International Airport. Plan to stand with us as we welcome veterans and their guardians returning from their day trip to Washington D.C. Consider joining us at the after dinner where we frequent La Bamba's in the Harbor Shops off 17th Street Causeway and Cordova Road.

On the Color Guard - consider joining us as a guardsmen. You do not need to have an approved application to join. We can outfit you in militia attire for less than \$500. The Color Guard is the face of the SAR when we are present as a unit at local, state and national events. Help promote the SAR and the values we represent by considering membership. Get something more out of your membership and ioin us at some of these non-luncheon events.

As we continue hearing about the many celebrations of the 250th anniversary planned for 2026, a brief update on the SAR Education Center and Museum seems timely. SAR is presently in the middle of the construction of the Museum's walls and building systems having a year-end targeted completion date. Then the project moves into a five-phase effort to build out the necessary millwork, and develop exhibits, graphics, and interactives. The "soft" opening remains on schedule for mid-2026. With this opening, stationary, fixed exhibits, including the display of over \$3 million in artifacts will be in place. After the soft opening, interactive displays will be installed over a 42 month timeline - that is dependent on raising an additional \$6 million - for a final completion planned for 2029. Since 2023, the Chapter. through member donations. contributed 1776 dollars annually for the Museum Project. Those of you who may wish to make individual donations are encouraged to do so by visiting the SAR Foundation at www.sar.org.

I am also pleased to report that by the next meeting, we will have assisted 14 individuals in making application and obtaining membership with five current year approvals and six inductions, and the balance of nine current applicants expected to be approved by 2025 year end. Adjusting for year-end transfers, resignations or withdrawals, as well as additional newly approved applicants, we should see a change in net membership from our year beginning number of 80 to approximately 90 by year end.

GENERAL MEMBERSHIP MEETING SUMMARY – JUNE 21, 2025

At our June 21, 2025 meeting we had 14 members and 8 guests for a total attendance of 22. The Invocation was given by Tom Carpenter Jr.

Chuck Adams led the participants in reciting the Pledge of Allegiance. He then led the participants in reciting the SAR Mission Statement and the SAR Pledge. Jason Milgram gave the 250 Minute on Birth of the Continental Army - June 14, 1775.



Chuck Adams acknowledged the presence of our newest member and today's inductee, Jeff Little. He then recognized our newest applicant Samuel Frankel Jr and his wife Natalia. He said that our other new applicants since the last meeting are Trent Prock and David Pinney, both of whom are out of town this weekend. Also in attendance at this meeting is applicant Dan McMurtrie and his wife Linda. Chuck said that by the next meeting he will finish the family plan application for Dr. Robert Easton Jr who is also out of town this weekend. Chuck reported that we started the year with 80 members and we are now 83 members. By the end of this year we could be at or over 90 assuming the submission and approval of the current list of applicants.

Chuck Adams gave the Financial Status Report as of May 31, 2025. He stated that the June 2025 Newsletter has been circulated. It includes the Member Profile of Daniel E. McMurtrie whose application is expected to be approved by NSSAR in July 2025. He said that the newsletter also has a list of all currently known 2025 events of Chapter interest.

GENERAL MEMBERSHIP MEETING (cont'd)

Steve DePaul provided an update on the Liberty Tree Project. He said that he and the committee are working with Jim Clark for the dedication in early 2026 of a tree at the City of Tamarac's Veterans Park.

to move the date

of the dedication to March 14, 2025 in order to avoid conflict with other statewide and national SAR events. The cost of the project has increased from \$207,500 to \$225,000 as costs for several unknowns are now being included. Fundraising is on schedule bringing in the \$10,000+ target per month. He said that the website for the project should be fully functional in a week and there are links to multiple social media sites that promote the project and directs interested viewers to where they can go to make donations.

Mark Snider stated that the Executive Committee met on June 4, 2025. It amended the budget to authorize the transfer of \$387.11 from savings to checking.

On the Veterans Support and US Stark Memorial Award Committee, Mark stated that we currently have 5,514 points for the US Stark Memorial Report. For 2024, Mark reported that the Fort Lauderdale Chapter placed 13th in the nation and 1st in Florida in the 50-99 member category in 2024. Also, Florida had 20 of 32 chapters reporting, which is 62.5% of our chapters. On a percentage basis, Florida was 11th in the nation, and qualified the FLSSAR for the President General's Streamer.

Mark said that for those Compatriots who have military or war time service, they can be listed on FLSSAR's Florida Veterans Battalion and also be recognized for their service by National on their Veteran's Corps Roster. He asked that those qualifying Compatriots provide him with a copy of their DD-214 form and he will submit the applications.



Bob Walsh gave the 250 Anniversary Recognition Report entitled, Why Bunker Hill? A Look at the Lead Up to Battle June 17, 1775, which is also published in the June 2025 Newsletter.

On Youth Education Programs, in the absence of Kevin Shurte, Chuck Adams

said that the only outstanding issue for the 2024-2025 program is how the Chapter's and State's first place winner in the Middle School Brochure Contest, Madeline Maragh, ranks at National. This will be decided in July 2025.

For 2025-2026, he said that two of the contests will be initiated in the last quarter of this year but the six others will not get going until the beginning of 2026. Tom Carpenter Jr said that it is especially important to bolster the public school system with programs that enhance the curriculum on the founding principles, and that he wished to help in any way possible for next year's program. Jeff Little agreed and said he, too, would help on this effort. Chuck added that member donations are critical to sustaining these programs.

Chuck Adams inducted Compatriot Jeffrey Zane Little. Steve DePaul presented him with the Rosette recognition lapel pin.

Chuck Adams recognized Jason S. Milgram as our newest member of the Samuel Nicholas Camp #23 Color Guard. He presented Jason with a Certificate of Membership and a SAR Color Guard Challenge Coin.

Chuck Adams said that as chairman of the JROTC /Sea Cadet Medal Awards Committee, we were able to attend 23 award ceremonies out of the 31 conducted this year. We had similar success last year. For those committee members that made three presentations over the two year period, he was awarding them the Henry Knox Bronze Medal. For those that made three or more each year, he was awarding them one medal and a bronze cluster. He said that some of the recipients helped with hand deliveries of awards to the schools that we could not attend and that was also a qualifying factor. Chuck Adams presented the Henry Knox Bronze Medal to: Thomas Carpenter Jr., Herb Gardner, and Barry Moss. Chuck said that he also qualified to receive the medal. Chuck then presented bronze clusters to

Thomas Carpenter Jr and Mark Snider. He said that Paul Moore was awarded the medal earlier this year for his prior year service. Also qualifying for the medal is Greg Elder and Jim McHugh as well as Kevin Shurte for the bronze cluster, each of whom will receive their award at the next meeting. For this year's new committee member who is present, Chuck asked Mark Snider to present the SAR Veterans Committee Challenge Coin to Herb Gardner.

AMERICA 250 British Capture of Fort Ticonderoga July 6, 1777 By Kevin Shurte

Built by the French in 1755 as Fort Carillon, Fort Ticonderoga was a strategic military stronghold near the confluence of lakes Champlain and George. Its proximity to these key waterways made it a coveted commercial and military target in Colonial America, changing hands numerous times among the French, British, and American forces.

Early in America's war for independence, a force under the command of Ethan Allen and Benedict Arnold stormed the fortress in a predawn raid. Their 4 A.M. assault on May 10, 1775, overwhelmed the sleeping and undermanned garrison, leading to the capture of the fort, its 48-men, over 100 cannons, and the commander's ample supply of rum. While Ethan Allen's Green Mountain Boys made off with the liquor, Colonel Henry Knox, Commander of the Continental Regiment of Artillery, absconded with 58 of its cannons, transporting them 300 miles overland to support the Siege of Boston. This first major victory significantly boosted American morale, and the fort remained in American hands until the British recaptured it in July of 1777.

Following Washington's defeat in New York, the British regained control of the Hudson River. Recognizing the strategic importance of the region's waterways, British General John Burgoyne proposed what would become the Campaign of

1777. His plan called for him to invade southward from Canada, capture Fort Ticonderoga, and move down the Hudson toward Albany while General Howe moved his men up the Hudson from New York. Together, they would capture Washington's forces in a pincer movement while severing New England from the southern colonies.

Burgoyne launched his campaign on June 17, 1777. Marching south from Saint John's, Canada with a force of 8,000 comprised of British regulars, Hessian mercenaries, American Loyalists, and Amerindians, Burgoyne reoccupied the abandoned redoubt at Crown Point on June 26 and prepared to besiege Fort Ticonderoga. Dividing his forces, Burgoyne sent the Hessians to contain the American troops at Mount Independence on the eastern shore of Lake Champlain while he advanced on Ticonderoga from the west.

Between July 2 and 4, British forces surrounded both garrisons by land and secured the high ground – Sugar Hill (also known as Mount Defiance), which the American commander, General Arthur St. Clair had declined to occupy due to its lack of fresh water. Upon finding Sugar Hill unsecured, British General William Philips remarked, "Where a goat can go, a man can go, and where a man can go, he can drag a gun" (Makos). British troops quickly cleared a road up the hillside, and by midday on July 5 had constructed an artillery battery armed with two twelve-pound cannons that loomed over Fort Ticonderoga and Mount Independence.

However, Britain's efforts had not gone unnoticed. Ticonderoga's defenders had observed their work on Mount Defiance and saw their campfires on the hilltop. Realizing that his position was untenable, St. Clair ordered a full and immediate retreat. That night, July 5-6, the sick, wounded, and camp followers were evacuated by boat on Lake Champlain, while the main body crossed the floating bridge to Mount Independence, and fled south toward Castleton in present-day Vermont.

The fall of Fort Ticonderoga stirred mixed reactions. St. Clair defended his retreat, saying that he had been outnumbered and had spared his army to fight another day. However, Americans, were shocked when they learned that St. Clair had surrendered the "Gibraltar of the North" without a fight. General Washington wrote that the "very extraordinary and sudden evacuation" was "altogether unaccountable"

(Schenawolf). In England, an elated King George III is said to have awakened his wife declaring, "I have beat them! I have beat all the Americans!" (Makos). The British and Hessians also marveled at their bloodless victory and the abundance of captured supplies but soon found their triumph short-lived. Within three months, they too would taste defeat just 75 miles south at the Battles of Saratoga.

SAR MEMBER PROFILE – BRADLEY M. MUELLER

Interviewed by Chuck Adams



Q. Ok Brad, tell us a little bit about yourself.

A. I was born in St. Louis, Missouri in 1952, but grew up in the neighboring suburb of Kirkwood. I was one of six children and a product of a combination of parochial and public school education

graduating from Kirkwood Senior High School in 1971 (go Pioneers). I earned a Bachelor of Arts in Science from Webster University in 1986 and a Master of Arts in Anthropology from Washington University In St. Louis in 1990.

Q. What is/was your occupation?

A. Following my graduation in 1990 I spent 22 years employed as a contract Archaeologist for several universities, numerous private companies, and the Navajo Nation in Arizona -- work which has taken me to most of the United States. In 2012 I accepted a position with the Seminole Tribe of Florida as the Compliance Section Supervisor in their Tribal Historic Preservation Office (based on the Big Cypress Reservation). I retired from the Tribe in October 2023.

Q. Tell us about some of your recreational interests and/or hobbies.

A. Being part of the Boomer generation my childhood hobbies included stamp and coin collecting. Christmas time was always special since my Dad would bring out the Lionel train set. I still have those collections, which I add to from time to time, as well as the train set. As an adult, I have become the *de facto* Mueller family archivist/historian, serving as the repository of family photos, documents, and ephemera.

Q. How about your family?

A I had the extremely good fortune of meeting my future wife, Jennifer, in Junior College (ca. 1972). She and I both worked on the student newspaper. I had sense (luck?) enough not to scare her off, and we were married on Valentine's Day 1976. We have two grown children, Hadley, the oldest, and Eric. In

1999, or thereabouts, Jennifer accepted a position with a company based in Sunrise, Florida. The four of us have lived in Sunrise since that time. Both of our children work full-time.

Q. Who is your Patriot ancestor?

- A. My Patriot ancestor is Joshua Hadley (1743-1815). As a Quaker, he furnished supplies in support of the troops in North Carolina.
- Q. Tell us about why you want to join SAR and whether you have plans on how you may want to get more involved with carrying out the mission and programs of the SAR.
- A. My interest in the SAR is an outgrowth of my wife's interest in her family's genealogy and her application and acceptance into the Daughters of the American Revolution (DAR). As she was pursuing her research/application, she was able to document my connection to Joshua Hadley my Patriot ancestor. I am linked to the Hadley line through my mother. At this particular time in our history, I felt it important to acknowledge and support the goals of the original patriots. How I will do this within the SAR is still to be determined.
