PRESIDENT'S MESSAGE

Compatriots and Friends,

As reported last month, all of our new member applications that were in the NSSAR pipeline have been approved. Compatriot Manson "Earl" Higginbotham, age 88, of Cooper City, Florida passed away on Tuesday, June 6, 2023, at Memorial Hospital West in Pembroke Pines, Florida. He was born on February 15, 1935, in Woodbine, Georgia.

He served in the United States Armed Forces from 1953 to 1975 retiring at the rank of Sergeant, First Class. For nine and one-half years he served with the United States Marine Corp and then he transferred to the United States Army. Upon enlistment, he started his military career serving in Korea. Later he served three tours of duty in Vietnam. He received numerous decorations for his service. Following his military career served as a Police Officer with North Miami Beach Police Department, where he not only was a patrol officer but also was their helicopter pilot retiring in 1989.

Earl was active in his community and a life-long philanthropist. He was a Past Master of North Shore Masonic Lodge, member of West Broward Masonic Lodge, a 33 Degree Scottish Rite Mason Valley of Miami, Past Potentate of Mahi Shine Temple, a DeMolay Chapter Dad, IORG Advisor, Jobs Daughters Associate Bethel Guardian, a member of the American Legion Post 321, member of the Sons of the American Revolution and Mr. Cooper City 2018.

He is survived by his wife of nearly 44 years Ellen Higginbotham and their daughter Danielle Higginbotham (Dominic Haywood). He is also survived by son Manson Scott Higginbotham (Cara Higginbotham), daughter Sherly Carey (Bill Carey), his brother Milton Wallace Higginbotham II (Peggy Higginbotham), grandson Finley Haywood, granddaughter Tanya Singer (Trevor Hoffman) and great grandchildren Ajay and Riley, and an unmeasurable amount of friends.

A funeral service for Manson will be held Saturday, June 17, 2023, from 11:00 AM to 1:00 PM at 4366 - Forest Lawn Funeral Home, 2401 Southwest 64th Avenue, Fort Lauderdale, FL 33317.

2023 SPRING BOARD OF MANAGEMENT (BOM) MEETING

The Florida Society Spring BOM was held May 19-20, 2023. I attended along with Steve De Paul and Kevin Shurte. I enjoyed going and will definitely go again. Here is a brief overview.

The first day (May 19th) consisted of several informational sessions and concluded with the Awards Banquet. On the second day (May 20th), the spring business and annual meetings of the Florida Society were held, and the day concluded with the Installation of Officers Banquet. This conference was considered a national event because President General C. Bruce Pickette was in attendance along with other national officers. Both banquets were opened with the presentation of colors by the Florida Colored Guard. Our Chapter member in period attire, Kevin Shurte, was invited to carry in the State Flag at both banquets. At the Awards Banquet, the Chapter was awarded second place for mid-size chapters in the 2022 Chapter Challenge. At the Installation Banquet, the Chapter contributed a basket to the Florida Ladies Auxiliary for their raffle. This is one of their standard fundraisers. They use the proceeds to grant cash awards and scholarships in the various youth programs that they participate in at the State level. Ironically, Steve De Paul won our basket of Jameson Whiskey and 1792 Bourbon.

The informational sessions held on May 19th included separate presentations on the importance of maintaining relations with the local C.A.R and the DAR. Participation with the C.A.R. can help chapters recruit C.A.R. male youth members to join the SAR as a junior member. For the DAR, developing relations with the local chapters to both participate in or cosponsor events was suggested. Again, the emphasis was on soliciting their membership for referrals of sons or grandsons who may wish to join the SAR. The Veterans Affairs session was cancelled but one of the State committee members held an informal discussion. Through this gentleman, he put me in contact with the Chairman of the NSSAR Veteran's Committee. Several days and multiple e-mails later resulted in the approval of Mark Snider as Representative and me as Deputy Representative to the volunteer's support committee (CDCE/VAVS) for the Broward VA Outpatient Clinic.

On May 19th a separate annual meeting was conducted by the Society of the War of 1812 in the State of Florida. It was interesting to learn that you do not need a direct line ancestor who fought in this war in order to join this lineage society.

As an example, your connection can be through a great...grand uncle as opposed to a great... grandfather.

On May 20th the Florida Society held its annual Spring Youth Awards Luncheon recognizing outstanding achievement among Florida youth. Kevin Shurte attended for our Chapter and provided this summary. "Following the opening ceremonies led by outgoing FLSSAR president Earl "Matt" Mathews, the FLSSAR and the Ladies' Auxiliary presented various trophies, achievement certificates, and cash awards in the amounts of \$1000, \$500, and \$200 to this year's winners of the Eagle Scout, Knight Essay, Historical Oration, and Enhanced JROTC contests. Officials also announced that the winner of the JROTC state award will be presented with the national award at this summer's NSSAR Congress being held in Orlando. Winners of the Elementary School Poster and Middle School Brochure contests were also announced after having been voted on the previous day by attending FLSSAR delegates."

At the May 20th business meetings, the primary outcome was the nomination and election of officers which are now posted on www.FLSSAR.org.

Some key takeaways:

Anyone volunteering to work on youth programs such as the C.A.R., Boy Scouts, etc. and the Color Guard are to take the online NSSAR Youth Protection Training course. Your certificate of approval is good for two years. A copy is to be e-mailed to the Florida Secretary of State and the Chapter President.

Going forward, newly approved Chapter members who provide a copy of their DD-214 will receive a medal and certificate for military or war time service from the Florida Society. A brief application transmitting the DD-214 to the Society's Committee Chairman of Veterans Affairs is all that is required.

A proposal will be considered at the 133rd Congress to raise national annual dues from \$35 to \$50. There has not been a national dues increase for 15 years. NSSAR has been running at breakeven or in deficit for some years as nationwide membership non-renewals run at about the same rate as new members added. Prior to Covid, NSSAR had about a 3% growth rate but now growth is flat or declining. The increase in fees will not only fix the budget deficiency but allow for the funding of some other initiatives. On approval, the change will take effect immediately upon the July 20, 2023 close of the congress.

250 ANNIVERSARY RECOGNITION

The following paraphrases SAR rules and guidelines on it's 250 Anniversary of the American Revolution Recognition Program. *The recognition program is designed to encourage and recognize those compatriots, chapters and societies that participate in local, state, national and international events which publicly educate, and recognize, honor, and celebrate the events and heroes of the period surrounding the American Revolution. Participation involves the planning and execution of these events, as well as attendance. The celebration of any event's 250th anniversary where said event related directly to acts of resistance to British attempts to coerce the residents in America: from the first Parliamentary Acts protested after the conclusion of the French and Indian Wars, through the armed struggle of the American War for Independence, to the ratification of the Treaty of Paris by the Continental Congress. This, therefore, will cover any public celebrations in the anniversary period from 2014 to 2033, or in the historic context, events occurring between 1764 to 1783.*

The Battle of Bunker Hill

Our next Chapter lunch meeting being held on June 17th has "250" significance. The Battle of Bunker Hill was fought 248 years ago on June 17, 1775. As hostilities with the British were ramping up, it occurred during the siege of Boston at Charlestown overlooking the Boston Harbor. British General Thomas Gage was in control of Boston and was attempting to secure Boston Harbor as a port of entry for troops, armaments and supplies. Leading up to the battle, at least 1,000 colonial troops commanded by Colonel Warren Prescott had occupied and fortified Breed's Hill which is immediately adjacent to Bunker Hill. The entire site comprising the two hills is now collectively referred to as Bunker Hill. The objective of the Americans was to deny the British unopposed control of Boston Harbor which was vulnerable to artillery fire from Bunker-Breed Hills as well as Dorchester Heights on the southeast side of Boston. The British launched throughout the day and early evening three frontal assaults taking significant casualties estimated at 1,000 compared to 450 Americans. The colonial troops had run out of ammunition during the third assault and exercised an orderly retreat giving the British a tactical victory. At the conclusion of the engagement, the continental troops lost General Joseph Warren who was not in command and was fighting as a volunteer. At the time, he was an important patriot and leader in the Sons of Liberty. Through their frontal assaults, the British had suffered the loss of numerous commissioned officers estimated at 89. For the Americans, the battle was significant since it proved to the British the worth and resolve of the colonial militias. While a tactical victory, it was not a strategic win. The British delayed and put on hold their plans to fortify Dorchester Heights. When General George Washington arrived some two weeks later to take command of the Continental Army, he realized its significance. Once he was able to assemble sufficient arms and artillery, he took the undefended Dorchester Heights in March 1776. This then forced the British to abandon Boston since without unopposed control of the harbor it no longer had strategic importance. The British would next take up positions in and around New York City and its harbor – but that is another story.

GENERAL MEMBERSHIP MEETING SUMMARY— MAY 13, 2023

At our May 13, 2023, meeting we had 18 members and 9 guests.

Chuck Adams gave the report on membership. He welcomed Jim McHugh and Lincoln Pero as new prospects and indicated that he was also working with Gary Van Sciver who was unable to attend. He said that year-to-date our membership has increased from 59 to 72 with an additional transfer-in of Ronald Goodale pending SAR approval. He said that the May 2023 Newsletter formalized the announcement by Joe Motes of his plan to move to Jacksonville by the end of this summer. The newsletter contains a "Help Wanted" article describing the various duties that Joe performs and asks members to consider volunteering to assume some of the responsibilities.

In the absence of Mark Snider, Peter Stevenson reported on the Executive Committee's zoom meeting held on May 8, 2023. With all members present, the resignation of Jim Lohmeyer as Chaplin was accepted. A **Motion** was made by Chuck Adams and seconded by Tom Shepherd appointing Tim McLane to serve as Chaplin during the 2023 unexpired term of Jim Lohmeyer, subject to the final approval of the general membership at its scheduled meeting of May 13, 2023. Unanimously approved.

Pete Stevenson gave Mark Snider's report on the Veterans Support and US Stark Memorial Award Committee. Among other things Mark is working with the coordinator of the Nininger Veterans' Nursing Home to identify items which are needed that the Chapter can assist with. He also plans for the Chapter to sponsor a Donut Saturday on June 24th at 10:30 a.m. He stated that on May 29, 2023, the City of Fort Lauderdale will hold a Memorial Day Ceremony at the Lauderdale Memorial Park Cemetery.

Steve De Paul gave an update on Fundraising, and Joe Motes gave the status of funds report. Joe also said that when he moves to Jacksonville, he will remain a member of this Chapter and will continue to help with things that he can do remotely. He particularly would like compatriots interested in taking on the JROTC and Sea Cadet medal and certificate program to let him know so he can help with the transition while he is still here locally.

A **Motion** was introduced by Chuck Adams, made by Pete Stevenson and seconded by Tom Shepherd to elect Tim McLane to serve as 2023 Chapter Chaplin for the unexpired term of Jim Lohmeyer. Unanimously approved.

Kyle Peterson, the newly elected President of the Swamp Fox Society C.A.R., reported on Swamp Fox activities over the past year and plans for the coming year. During 2023-24, the State and local societies will raise funds to support the Clearwater Marine Institute's research to save the endangered Right Whales. Kyle concluded by recognizing and thanking Joe Motes for his years of service to the Swamp Fox Society. Coleen Langford introduced herself as the Immediate Past President. She stated that they would welcome children and grandchildren from the Chapter to attend their meetings and join the C.A.R.

Chuck Adams presented C.A.R. representatives Kyle Peterson and Colleen Langton the Chapter's check for \$350 stating that it is the first of our two annual donations which will total \$700.

Chuck Adams inducted Robert C. Bowling and his son, R. Collier Bowling, Jr, welcoming them into the Chapter. Ted Duay assisted with the presentation of their Rosette. Chuck Adams also presented the SAR Membership Award Certificate and Pin to Allen Manning (25 years) and Ted Duay (20 years).

Chuck Adams presented a certificate and medal for war time service to: Thomas Carpenter Jr (U.S. Navy - Vietnam), Rick Kidder Jr (U.S. Navy - Iraq, Southwest Asia & Global War on Terrorism), and Tim McLane (U.S. Air Force - Saudi Arabia/Southwest Asia).

Under unfinished and new business, Chuck Adams provided the update on the efforts to form a Chapter Color Guard which should be finalized after his return from the Florida Spring BOM being held May 19-20, 2023.
